

Stratford Town Football Club Lottery

RULES

1. This lottery is organised by Stratford Town Football Club for the purposes of raising funds for the development of Stratford Town Football Club and the community facilities.
2. All entrants to the competition will be deemed to have accepted these rules and regulations.
3. Applications must be by players aged 16 years or over and be on Stratford Town Football Club Lottery forms.
4. The cost of each entry is £1 per week. Players may purchase more than one entry and payment must be made in advance by standing order directly into the Stratford Town Football Club Lottery account.
5. These payments may be paid monthly, quarterly, half-yearly or annually.
6. On receipt of confirmation that the payment has been made the club promoter will allocate the applicant a number(s) unique to that applicant for the duration of the Stratford Town Football Club Lottery. The promoter will place the applicant's number in the list of numbers to be drawn in the next calendar week after receipt of the first payment from the applicant. Upon receipt of that payment, the applicant shall become a member of the Stratford Town Football Club Lottery.
7. The promoter is not responsible for any delays in bank payments
8. Cards will be issued to members of the Stratford Town Football Club Lottery and will include the following information:
 - The membership price
 - The members unique number(s)
 - The promoters name and address
 - The local authority registration number
9. Numbers allocated will be 1-500 and the prize fund will be 50% of the weekly entry fees
10. No prize will be paid other than to the person named on the application.
11. A draw will be made at the club in each calendar week and will be witnessed by at least two Stratford Town Football Club members. The winning number will be randomly selected from all numbers sold.
12. Any person found to be under 16 years of age will automatically forfeit the right to any prize
13. The number of entries will determine the value of prizes
14. All prizes will be paid by cheque and the promoter will endeavour to distribute prizes no later than fourteen calendar days after the winner has been announced.
15. Results will be posted on www.stratfordtownfc.co.uk and on the notice board in the club house
16. No alternative to the prize will be offered and the promoters decision is final
17. Membership of the Stratford Town Football Club Lottery shall cease forthwith upon one of the following events:
 - Death of the Lottery member
 - Non payment of any standing order
 - A player giving one month's written notice to the promoter on or before the 30th day of the month that he/she wishes to cease to be a participant in the lottery. No monies received from the player prior to cancellation will be repaid other than prizes.
 - The promoter gives a minimum of three months notice of termination of the lottery.
 - The dissolution of Stratford Town Football Club.
18. The promoter has the right to change or update the rules at his discretion.
19. The lottery is organised by Stratford Town Football Club and is registered with Stratford-on-Avon District Council as a small society lottery under the Gambling Act 2005

You may at times be asked to supply personal information. Personal information is anything which enables us to identify you in some way, such as your name, address and email. If you supply such information, we are legally bound by the Data Protection Act 1998 to ensure that such information is only used for the purpose for which it was requested and also to ensure that the data is held securely.

Stratford Town Football Club Lottery is registered with Stratford upon Avon District Council as a small society lottery and conforms to the Gambling Act 2005 – registered no GA05 SDC 550042
